Dear Mari.

Thank you for your reply. I understand that North Redington Beach does not currently have properties deemed historic and that no specific ordinances are in place.

Over the past month, I have been working with Tom Scofield, the Pinellas County Historic Preservation Planner, who connected me with Dr. Kyra Lucas, Supervisor at the Florida Department of State's Bureau of Historic Preservation. They have provided guidance on the process and on the documentation required for consideration. We have submitted a preservation package for review, and while I know eligibility has not yet been decided, I would like to better understand how this process intersects with local ordinances and the City's role if eligibility is granted.

As background, the Islander (17006 Gulf Blvd) appears to be one of the earliest multi-unit apartment-style properties (12–16 units, larger than the 4–6 unit cottage or tourist courts) in North Redington Beach. It reflects the transition from small cottages to purpose-built apartment/motel complexes that later became common along Gulf Boulevard. This context is part of why we believe it may meet criteria for historic significance.

In addition, I would like to learn whether the Town has any records or resources that could help clarify the property's early history as we continue our research.

For these reasons, I would greatly appreciate the opportunity to meet with Mayor Super directly. I have attached the preservation package for reference, which outlines the property and its significance, and I would be grateful if you could share it with the Mayor in advance.

Thank you again for your time and assistance. I look forward to hearing when a meeting might be arranged.

HI Mari,

Thank you for your kind words about the preservation package (it has truly been a labor of love) and for offering to check what resources the Town may have. That is greatly appreciated.

To help guide the search, here are some types of materials that could help clarify the Islander's early history and significance:

- **Historic photographs** particularly aerial views, postcards, or publicity photos of Gulf Boulevard and North Redington Beach from the 1940s–1960s that may show the Islander or surrounding properties. Specifically, what we are looking for is an aerial photo of 1947-1949 (the islander was built in 1948) so a photo showing what other properties were built would be very helpful.
- **Permits, applications, or approvals** any early building permits, site plans, or variances related to multiunit apartment or motel construction.
- **Town meeting minutes or records** notes from commission or planning meetings where multi-unit properties such as the Islander "Dolphin Apartments" were discussed.
- Maps or plats subdivision maps, zoning maps, or early town development plans that show the Islander "Dolphin Apartments" and its context among smaller cottage courts.
- **Directories or promotional materials** brochures, tourism materials, or business directories listing the Islander or other early apartment-style complexes.
- **Newspaper clippings** if the Town has archives that reference the Islander's "Dolphin Apartments" opening, operation, or role in the community.

Our goal is to document how the Islander fits into the transition from small cottages and tourist courts to larger purpose-built apartment/motel complexes along the barrier islands. Even a single photo or mention in the records could help substantiate its place as one of the earliest of its kind in North Redington Beach.

Thank you again for taking the time to assist with this search. Please let me know if I can provide any additional details that might make the process easier.
