Hi Eleanor,

Heres the updated Historical Preservation Package. I made the few changes that we discussed.

Also on another note I wanted to let you know I had a nice conversation with Dr Kyra Lucas who is the supervisor of the bureau of historic preservation for the Florida department of State and while we were on the phone I emailed her the package. She reviewed it and she is presenting it to her team on Monday so we will have an answer on Monday or Tuesday whether they feel that the Islander is eligible for full review. If they have additional questions they will let us know.

She did ask if we knew when the peaks on the buildings were added and then removed. According to the photos that I have from 1964 they're not on the original buildings when they were built but if you look at the package and you look at the brochure from 1983, it shows the peaks on the west side of the buildings and in the following page where it shows the second brochure you see the peaks in the pictures they wanted to know when those were removed. So if you or anybody else knows that would be great.

And any other pertinent information like changes that were made to the buildings or anything that would be great too.
